## Next Steps

Based on your input, York Region will identify a recommended alternative and finalize the types and locations of improvements associated with that alternative. We will come back at Public Consultation Centre (PCC) #3 to present the recommended alternative and the associated improvements. We will then begin the next stage in the Individual Environmental Assessment, which is called "Alternative Methods of Carrying Out the Undertaking". This stage involves:

- Developing alternatives for each of the improvements (e.g., how could the roads be widened and configured?)
- Going into the field to collect additional information about the environmental features that might be affected by each improvement
- Evaluating and comparing the various alternatives associated with each improvement to identify which ones have the least impact on the environment and the greatest benefit to the transportation network

We will bring back a more refined plan during PCC #4 that shows the alternatives for each of the improvements and we will seek your input again before finalizing the improvements that will be carried forward for preliminary design.
